

## Contest Rules

### ChargeHub Photo Contest

from 6:00 am on May 19th 2023 EST to 11:00 am on August 31st, 2023 EST  
("Contest Period")

#### 1. HOW TO ENTER

**No purchase required.** To enter the Contest, visit the EV Society Website at [www.https://evsociety.ca/contest](https://evsociety.ca/contest) (the "Website") during the Contest Period.

Limit of one entry per person for each charging station. To be valid, entries must be received by 11:59 p.m. August 31, 2023 EST.

#### 2. ELIGIBILITY

Contest is open to all Canadian residents, who are EV Society members and have reached the age of majority in their province or territory of residence at the Contest opening date.

#### 3. PROCEDURE FOR AWARDING PRIZES

In the second week of each month during the contest period a random draw will be conducted by EV Society from all eligible entries received from the month before. The Grand Prize will be awarded to the top three EV Society members who have had the highest number of eligible photos uploaded on the Chargehub App from May 19th - August 31st. The grand prize winner will be announced on September 15th. The winners will be announced via Email and on EV Society Social Media Channels. Winners should claim their prize as instructed by EV Society by no later than 7 days after the date they are initially contacted. If a winner cannot be reached within 7 days following the first attempt of contact, declines the prize, the prize shall be forfeited and EV Society has the right, at its sole discretion, to select another winner.

#### 4. DESCRIPTION OF PRIZE(S)

**Each month there will be three draws:**

1. \$200 ChargeHub charging credit plus a two year ChargeHub Passport Membership.
2. \$100 ChargeHub charging credit plus a two year ChargeHub Passport Membership.
3. One-Year membership to EV Society (valued at \$50 to put towards your next membership).

**Grand Prizes:**

1. \$500 ChargeHub charging card plus a two year ChargeHub Passport Membership.
2. \$500 Amazon gift card
3. One Yet-E-Boot Charge Port Protector premium package (valued at \$150 shipped to you anywhere in Canada).

5.1 The prize shall be accepted as is and may not be exchanged or refunded for an amount of money, sold or transferred. No substitutions will be allowed. Any unused portion of a prize will be forfeited.

5.2 If the prize cannot be awarded as described in these rules, EV Society reserves the right to substitute a prize or prize component with another of comparable value, as determined in its sole discretion.

5.3 Refusal to accept the prize releases the Contest Parties from any obligation toward the winner.

5.4 The Contest Parties assume no liability for any loss, damage or injury, including without limitation: (i) lost, stolen, delayed, damaged, misdirected, late, destroyed, illegible or incomplete entries; (ii) loss, theft or damage; (iii) inability of any person to participate in the Contest for any reason including e-mail; technical, computer or telephone malfunctions or other problems with computer on-line systems, servers, access providers, computer equipment, or software; congestion on the internet or at any website, or any combination of the foregoing; (iv) damage to any person's computer, including as a result of playing or downloading any material relating to the Contest; (v) any delay or inability to act resulting from an event or situation beyond their control, including a strike, lockout or other labor dispute at their location or the locations of the organizations and businesses whose services are used to administer this Contest; or (vi) prizes that are lost, damaged or misdirected during shipping.

5.6 . If the identity of a contestant is disputed, the authorized account holder of the email address linked to the EV society's membership at the time of entry will be deemed to be the

contestant. The individual assigned to the e-mail address with the EV society's membership is considered the authorized account holder. All entries must be submitted from a valid e-mail account that may be identified by reverse domain name search. The sole determinant of time for the purposes of receipt of a valid entry in this Contest will be the Contest server.

5.7. Odds of winning depend on the number of eligible entries. All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, using any robotic, automatic programmed method that artificially increases the odds of winning or do not conform to or satisfy any condition of the rules may be disqualified by the EV Society. EV Society is not responsible for any errors or omissions in printing or advertising this Contest.

5.8 For the grand prize selection, In the event that there are more than three participants who have submitted the highest and exact same number of photos, a random draw will be conducted to determine the winners among those individuals. The draw will be conducted in a fair and transparent manner, using a random selection method approved by the contest organizers. The winners will be selected from the tied participants, and the decision of the random draw will be final and binding.

5.9 EV Society reserves the right to amend the Contest rules or to terminate the Contest at any time without any liability to any contestant. Any amendments to these Contest rules will be posted on the Website.
